



School of Nursing Compliance Requirements (Exxat)

By accepting admission into the UW School of Nursing, students agree to meet all School of Nursing compliance requirements and maintain compliance throughout the duration of their program. Compliance requirements are established in accordance with University policies, School of Nursing requirements, and the requirements of our clinical partners.

Students are responsible for completing all required compliance items by established deadlines and maintaining current documentation throughout their enrollment, even if requirements are added, modified, or updated during their time in the program. Students may also be required to meet additional compliance requirements requested by individual clinical agencies or placement sites.

The School of Nursing utilizes **Exxat**, a cloud-based clinical education management platform, to track compliance requirements, clinical placements, evaluations, timesheets, and other clinical learning activities. Students are required to create and maintain an active Exxat account and are strongly encouraged to begin reviewing and submitting compliance documentation as soon as possible.

Failure to meet compliance requirements by established deadlines may result in delays to clinical placement, ineligibility to participate in clinical experiences, registration impacts, or an inability to progress in the program.

Important Due Dates

June 15, 2026

- Begin submitting compliance documentation through Exxat.
- Register for your CPNW account.

August 7, 2026

- Deadline to submit **all** required compliance documentation through Exxat.

You should have received a welcome email from **Tyraina Berry, Clinical Programs Systems Administrator**, introducing Exxat and providing helpful resources and tutorials. You should have also received an invitation from Exxat to create your account.

Exxat requires an active UW NetID and UW email address for access. Students must be admitted to **and** have accepted admission to the University of Washington (not just the School of Nursing) before activating their UW NetID and UW email account. Once your UW credentials are active, you should be able to access Exxat and begin setting up your account.

Exxat Account Setup Fee: Students are responsible for a one-time account setup fee paid directly to the Exxat vendor. Please review Tyraina Berry's emails for current pricing information and payment instructions.

School of Nursing Compliance Requirements (Exxat)

Once you receive your Exxat invitation, you will need to complete the following steps to begin your compliance process:

1. Activate your Exxat account and complete your student profile.
2. After logging in, navigate to the Compliance section and carefully review all requirements and their associated instructions before submitting any documentation.

We strongly encourage you to begin reviewing compliance requirements as soon as possible. Some items may take several weeks to complete, and starting early will help ensure you have enough time to resolve any issues before the compliance deadline.
